### Brother Knights,

And of course in Germany what is a Christmas Market without some sausage, cheese and little beer and wine tasting. It was a very family oriented and joyous event. I always wondered why we are called Knights of Columbus. In 1881, Fr. McGivney, a young Irish priest based in New Haven, Connecticut, explored his idea to begin a new type of fraternal organization. He hoped it would not only bolster the men's faith at the parish, but also provide financial relief for families stricken with the death or sudden illness of the breadwinner. McGivney knew firsthand the effect this had on a family, especially an immigrant family struggling to make it in America. The fraternal groups that, at the time, served as the most common source of life insurance were closed to Catholics and immigrants. After much consultation Fr. McGivney started the "Sons of Columbus" in 1882, named in such a way as to bind Catholicism and Americanism together through the faith and bold vision of the New World's discoverer. The word "Sons" was soon replaced by "Knights" to further invigorate the men who would become members. Fr McGivney ... understood that using Columbus as their Order's namesake asserted an important truth: that not only was there a place for Catholics and immigrants within American society, but that such a person had already played a part in creating the young, free world around them.

The Columbiettes are having a Yard and Bake sale on October 13 at the council. They are also having Family Bowling on November 3 at Sayville Bowling Lanes. Please come out and show your support of these charity events for our sisters. Our council and families are so bless to be able to give back to the less fortunate in our community and support the church. Always remember it's better to give than receive.
